What is Accreditation?

- Accreditation--through the Council on Education for Public Health (CEPH)
- Accreditation assures that programs abide by standards--statements that define and set expectations about fundamental essentials for educational quality

Is CEOMPH Accredited?

- Accredited since 2003
- Re-accredited in 2009 for 7 more years
- Next site visit in 2016



What Is The Plan?

- Gather data
- Determine aspects to change
- Determine changes needed
- Implement changes
- Incorporate into self-study

Timeline

Survey Results

Survey—Mission/Values/Goals

- Mission statement—70/72 like it; changes to wording
- Values—70/72 like it; changes to wording and consider other values
- Goals—67-72/72 like them; need to focus
 - Teaching/education
 - Research
 - Services
 - Administration/planning

Survey--Competencies

- Strengths—coursework reflects, broadbased, detailed, address public health
- Weaknesses—too detailed, too many, include specific ones

Survey--Diversity

- Strengths—idea diversity, students, professionals, backgrounds
- Weaknesses—more MD students, no instruction about incorporating, look into social determinants

Survey—Student Advising

- Strengths—open communication, professionals in field, passionate advisors
- Weaknesses—confusing class scheduling, more individual level career counseling, guidance choosing electives, not advised on careers

Survey—Research

- Strengths—organized, options for collaboration, capstone
- Weaknesses—not many opportunities, outdated suggestions, need foundational course

Survey—General Program

- Strengths—online/Saturday class, faculty experience, communication, organized, networking opportunities, flexibility
- Weaknesses—update website, too general, structural barriers, not resourced well, lack of specializations, professional writing

Survey--Opportunities

- Job opportunities due to aging workforce
- Public health network
- Rural Ohio initiatives
- Agency decreased funding—maybe would like more interns

Survey--Threats

- Competition from nearby MPH programs
- Decreased funding
- Employers not valuing MPH
- Saturation of job opportunities from many MPH graduates from the 7 programs in Ohio
- Overburdening of agency sites for placements from other programs

Survey—Future Directions?

- Interest in DrPH—29/44
- Specialization tracks
- Expand grant writing, research, funding opportunities for staff
- Expand medical collaborations
- Change name
- Improve recruitment and cost effectiveness


